Behavior analysis, a rapidly growing profession, began with the use and application of conditioning and learning techniques to modify the behavior of children or adults presenting severe management problems, often because of developmental disabilities. Now behavior analysts work in a variety of settings, from clinics and schools to workplaces.

Especially since their practice often involves aversive stimuli or punishment, they confront many special ethical challenges. Recently, the Behavior Analysis Certification Board codified a set of ten fundamental ethical guidelines to be followed by all behavior analysts and understood by all students and trainees seeking certification. The authors first describe core ethical principles and then explain each guideline in detail, in easily comprehensible, everyday language. The text is richly illuminated by more than a hundred vivid case scenarios about which the authors pose, and later answer questions for readers. This handbook explores the rapid growth in childhood developmental disabilities (DD) treatments. It reviews current evidence-based treatments for common psychopathologies and developmental disorders and evaluates the strengths of the treatments based on empirical evidence. The Handbook of Childhood Psychopathology and Developmental Disabilities Treatment is a must-have resource for researchers, graduate students, clinicians, and related therapists and professionals in clinical child and school psychology, pediatrics, social work, developmental psychology, behavioral therapy/rehabilitation, child and adolescent psychiatry, and special education.

Albert J. Kearney explains the kinds of learning and reinforcement processes that form the basis of ABA programs. He then describes how the science of behavior analysis can be applied to real life problems. He looks at how behavior is assessed and various intervention techniques that are often employed with children who have special needs.

In a conducted study results yielded that children ages 1.5 to 3 years, who were previously diagnosed with Pervasive Developmental Disorder, significantly reduced self stimulatory, repetitive and compulsive behaviors, and built compliance and the ability to complete required tasks after applied behavioral analysis was administered. The dependent study monitored 15 participants and randomly assigned them into one of two groups. The control group consisted of 8 participants who did not receive ABA therapy. The second group containing 7 participants received ABA therapy. Children selected were comparable in chronological and mental ages, diagnosis, disabilities and geographic location. ABA therapy was administered at each participant's home for an average of 13 hours each week for 10 weeks. ABA was the only therapy administered throughout the study. ABA therapy was solely applied to the ABA group and not applied to the control group. As a result, the participants in the control group scored significantly lower when tested. The ABA group advanced substantially farther than the control group.

Abstract: Children with Autism Spectrum Disorder (ASD) have progressed much from treatment and intervention from Applied Behavior Analysis (ABA). Unfortunately, the families receiving treatment face a number of struggles from the initial diagnostic process, to the search for appropriate services, financial burdens, management of behaviors and caring for a child with ASD among everyday life stressors. Although appropriate ABA services may be in place and implemented in a professional manner to serve children with ASD, the overall stressors families face can impede the relationship between behavior therapy staff and families which can affect the progress of a child. Therefore, the intended purpose of this grant thesis proposal is to seek funding for a research trial of an ABA staff development program. This program would be designed to target a systems theory perspective in hopes of creating an

awareness of the challenges families of children with ASD face, which ultimately may affect progress of a child. Although actual submission of this grant proposal is not requirement for thesis completion, a realistic host agency is needed. Easterseals Southern California Autism services-ABA department has allowed partnership for this project.
