How to Follow FTC Buyer's Guide Rules to Avoid Fines at ...

Any car dealer or person that sells 6 or more motor vehicles in a 12 month period is required by Federal Law to follow the FTC Buyers Guide Rule, which includes posting a Buyers Guide on every vehicle held for resale.
