Robert Frank's Microeconomics and Behavior covers the essential topics of microeconomics while exploring the relationship between economics analysis and human behavior. Techniques for studying ordinary differential equations (ODEs) have become part of the required toolkit for students in the applied sciences. Standard analytical methods for first- and second-order equations are covered first, followed by numerical and graphical methods, and bifurcation theory. Higher dimensional theory follows next via a study of linear systems of first-order equations, including background material in matrix algebra. A phase plane analysis of two-dimensional nonlinear systems is a highlight, while an introduction to dynamical systems and an extension of bifurcation theory to cover systems of equations will be of particular interest to biologists. With an emphasis on real-world problems, this book is an ideal basis for an undergraduate course in engineering and applied sciences such as biology, or as a refresher for beginning graduate students in these areas.

Also, three new chapters have been added: the global overview of fixed income markets; a chapter on corporate bonds and credit default swaps; and a chapter on discounting with bases, which is the foundation for the relatively recent practice of discounting swap cash flows with curves based on money market rates.
