What not to put in a position paper Parties should think carefully about including statements that might be seen as offensive. A Position Statement is a permanent record of a party ' s position, ever present throughout the mediation. If it contains unhelpful comments, this may prove to be a barrier to effective dialogue.

In a position paper assignment, your charge is to choose a side on a particular topic, sometimes controversial, and build up a case for your opinion or position. You will use facts, opinion, statistics, and other forms of evidence to convince your reader that your position is the best one.
